MINUTES: The minutes for Sep. 17th, Sept. 29th and Oct. 1 were reviewed. Bill Barnhill made a motion that all 3 sets of minutes be approved as modified and Brent Barrus 2nd the motion. Voting was unanimous in the affirmative.

DISCUSSION ON PUBLIC HEARING: After review of the city code book, a motion was made by Brent Barrus to wave further discussion . This was 2nd by Eileen Kershaw and all approved. A motion was then made by Brent Barrus that the application for the fertilizer plant be

approved subject to conditions set forth in the code book. [see Sugar City Code 964 A (5)] requiring adequate plans, specifications and design sketches. They will also need a building permit. The motion was 2nd by Tyson Harris and the vote was unanimous in the affirmative. Dave will attend the next City Council Meeting and present the proposal and if approved he will take it to Madison Co for approval.

OLD FARM ESTATES: Jeff Lerwill presented a new map of their proposals for high and low density development. They are waiting to hear from engineer, Dick Dyer, to move forward with plans. Water issues were discussed and Brent Barrus made several suggestions of resource people who might be helpful. There was also discussion of the north west corner of the property and concern about adequate safety of entrances and exits to the property. They will be working on finalized plot maps and more information.
